1 Product Overview

The Clock Kit enables the CyberData V2 VoIP Ceiling Speaker to be upgraded to a highly visible public address device with a time display.

Note The Cyberdata speaker is not included with this kit.

The large display characters are easily read and adjust for ambient light conditions. Time sync is performed by NTP and a built-in real-time clock.

Power is supplied by the CyberData V2 Speaker from a single PoE connection.

Note Prior to installation, create a plan for the locations of your SiP VoIP and PoE Speaker.

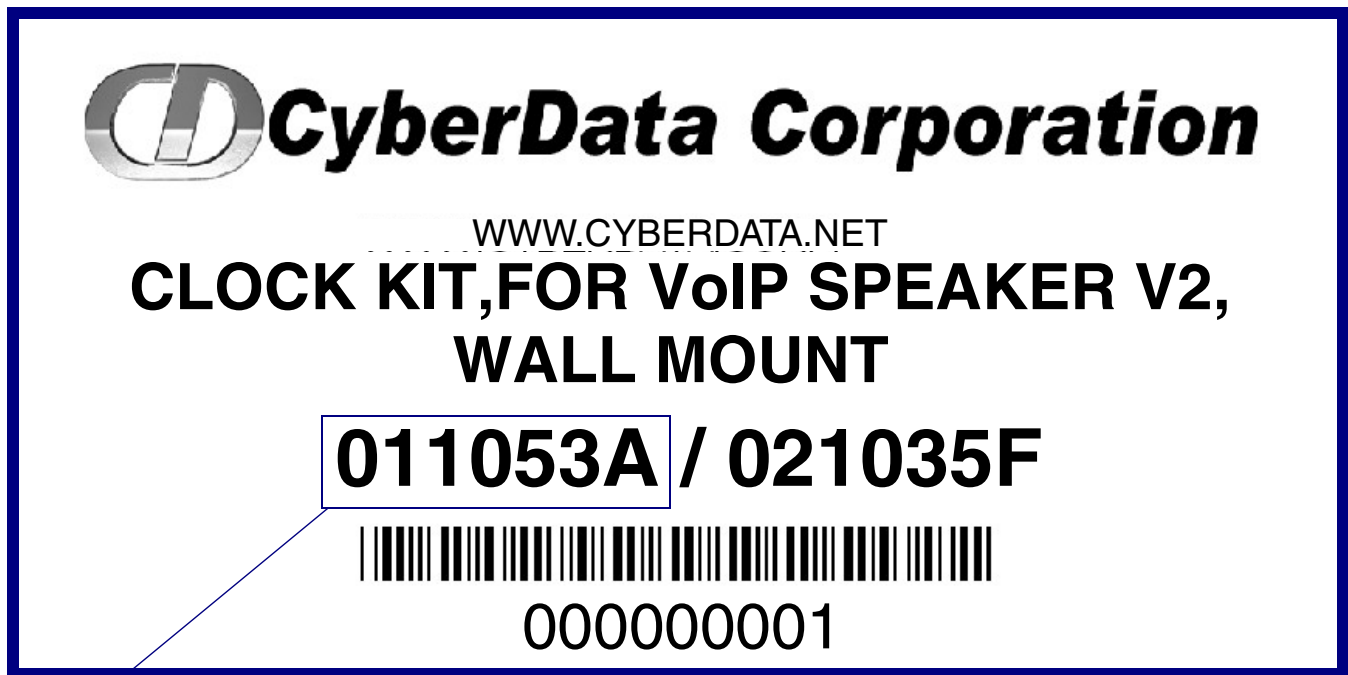
1.1 How to Identify this Product

Figure 1-1. Model Number Label

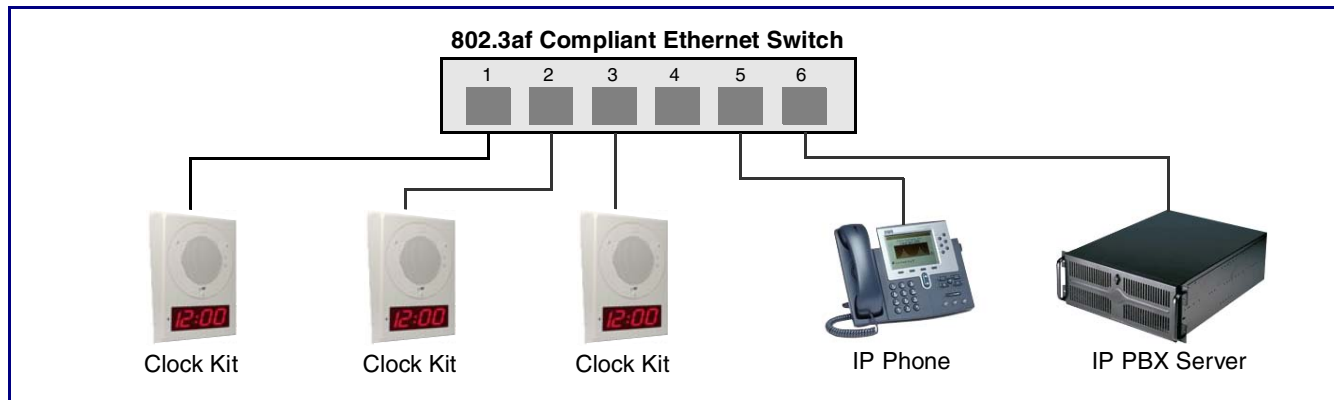

Figure 1-2. Typical Installation

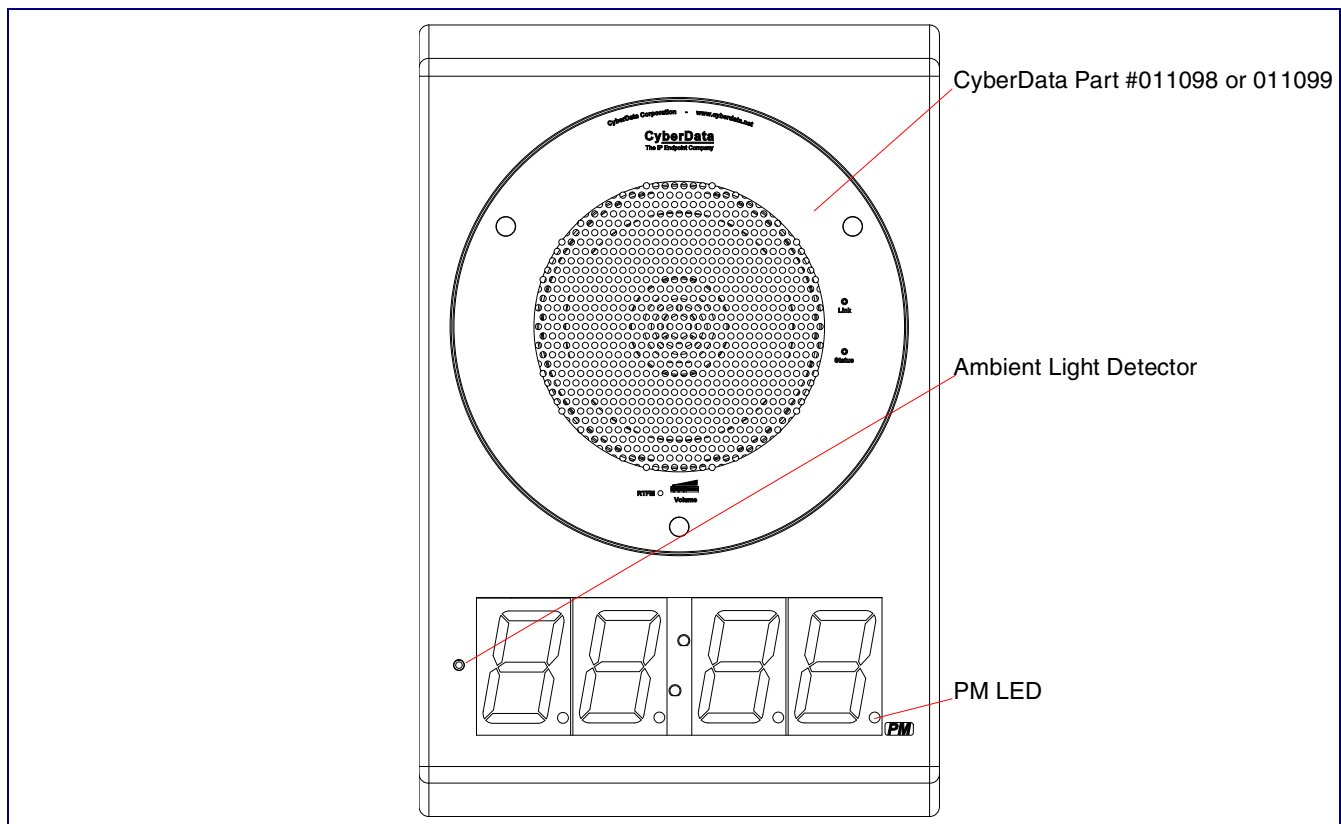

Figure 1-3. Feature Locations



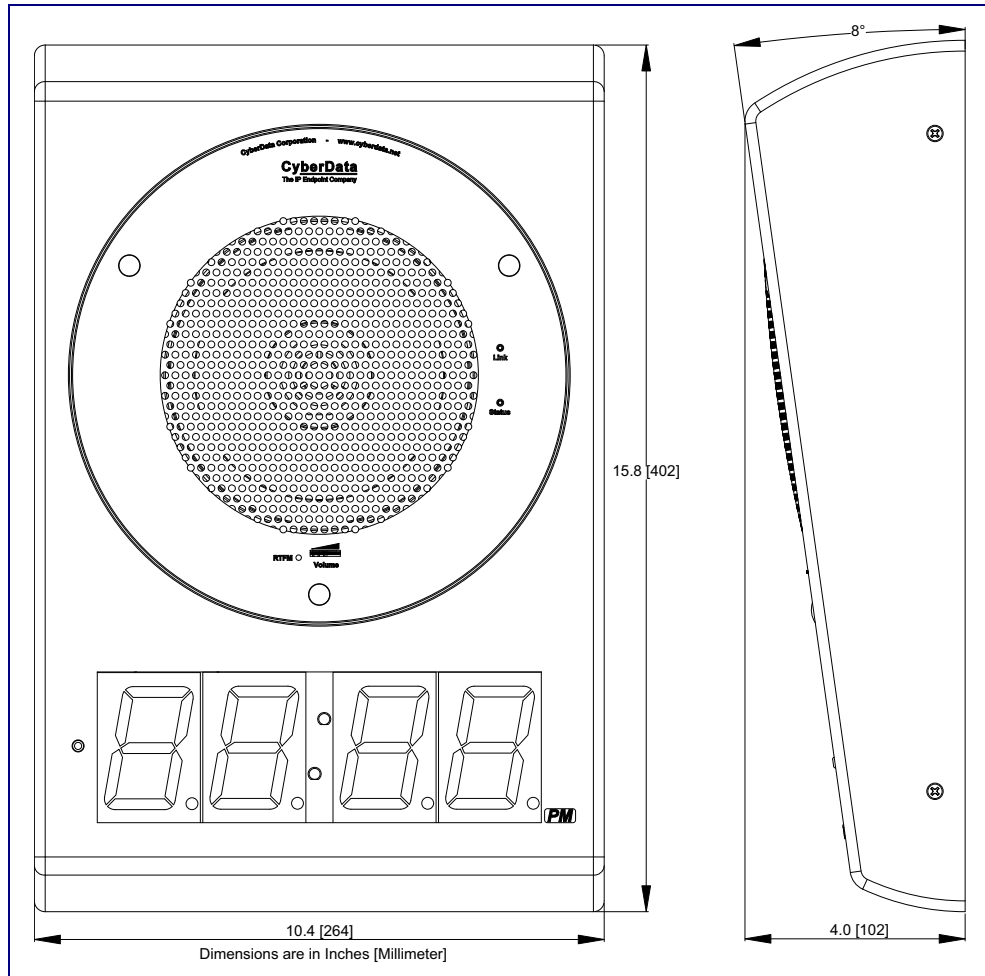

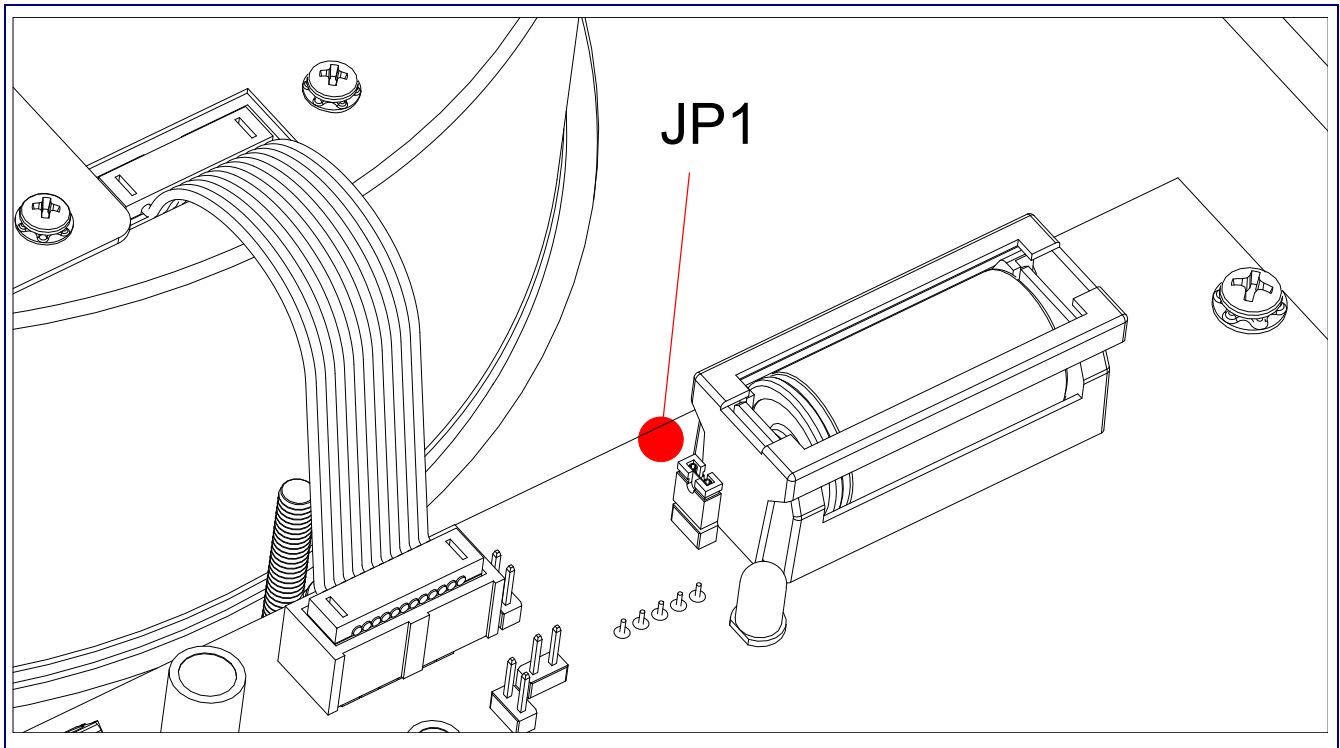
2.1 Pre-Mounting Connections

2.1.1 Install JP1 Prior to Clock Kit Installation

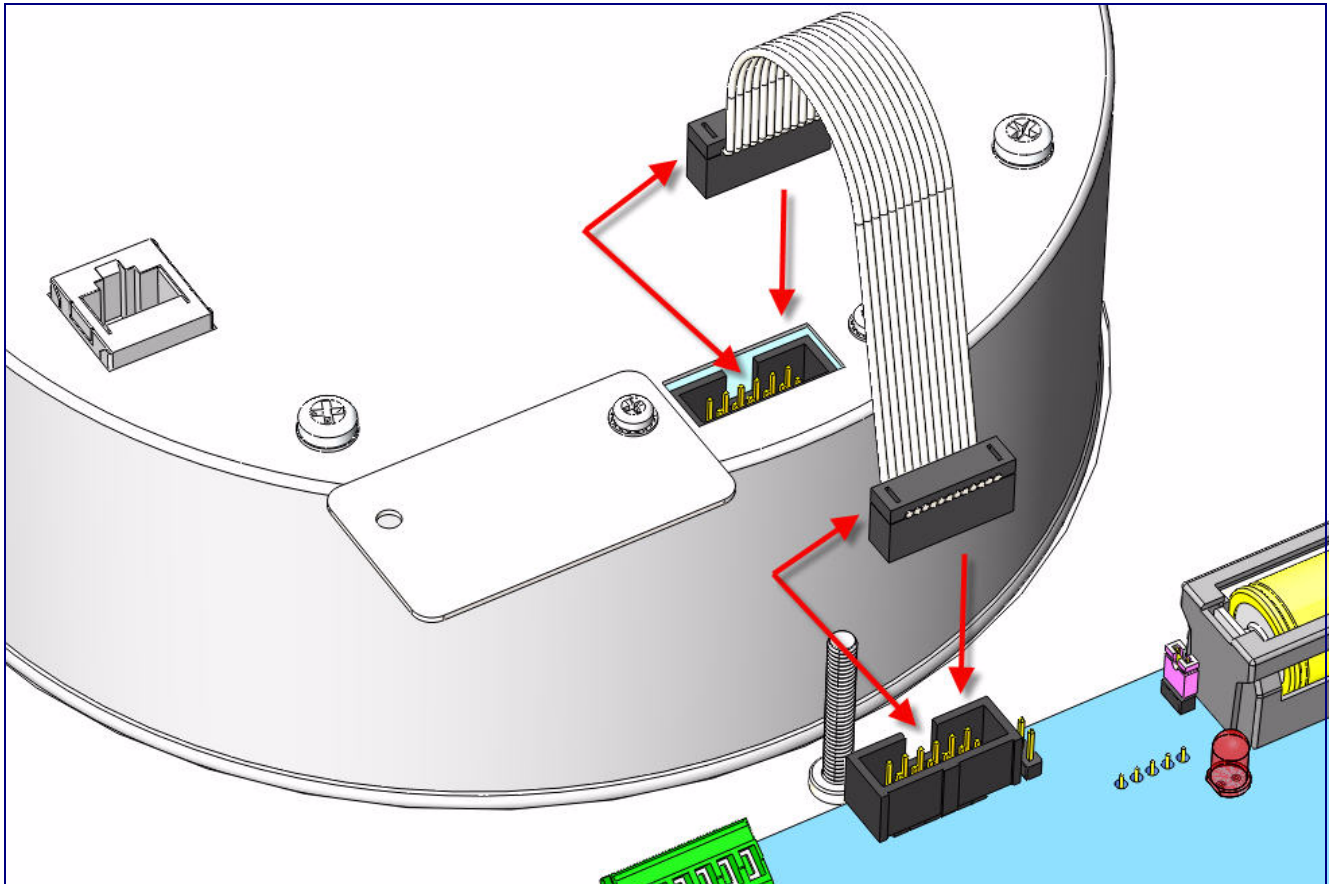
Figure 2-5. Jumper JP1

To enable the battery for real-time clock operation, install a jumper on JP1 as shown in [Figure 2-5](#).

Note This jumper ensures that the clock will not lose the time setting in the event of a power outage.

2.1.2 Connecting the Clock to the Speaker

2.1.3 Connecting Power to the Speaker

Note Prior to mounting, you can route the Ethernet cable through the back or through the slots at the top or bottom of the Clock Kit Adapter.

Figure 2-7. Connecting Power—PoE

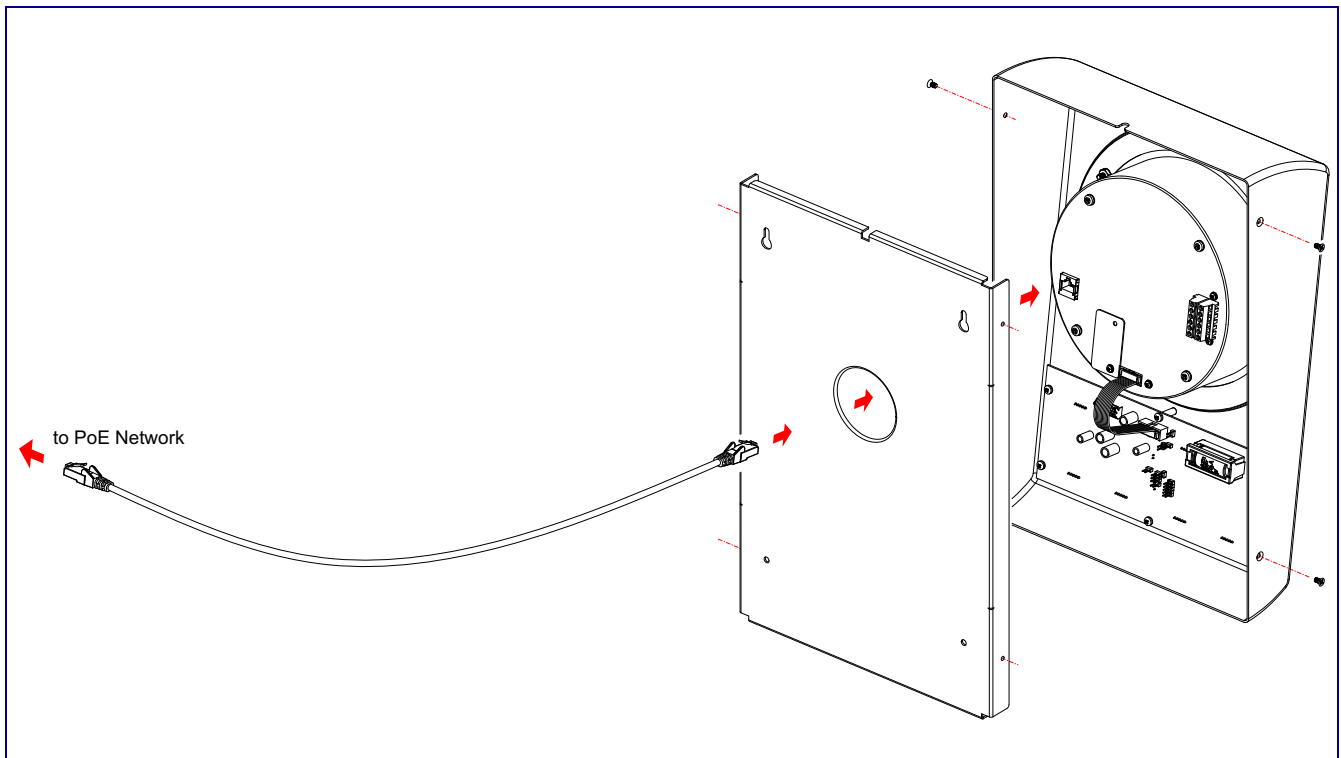
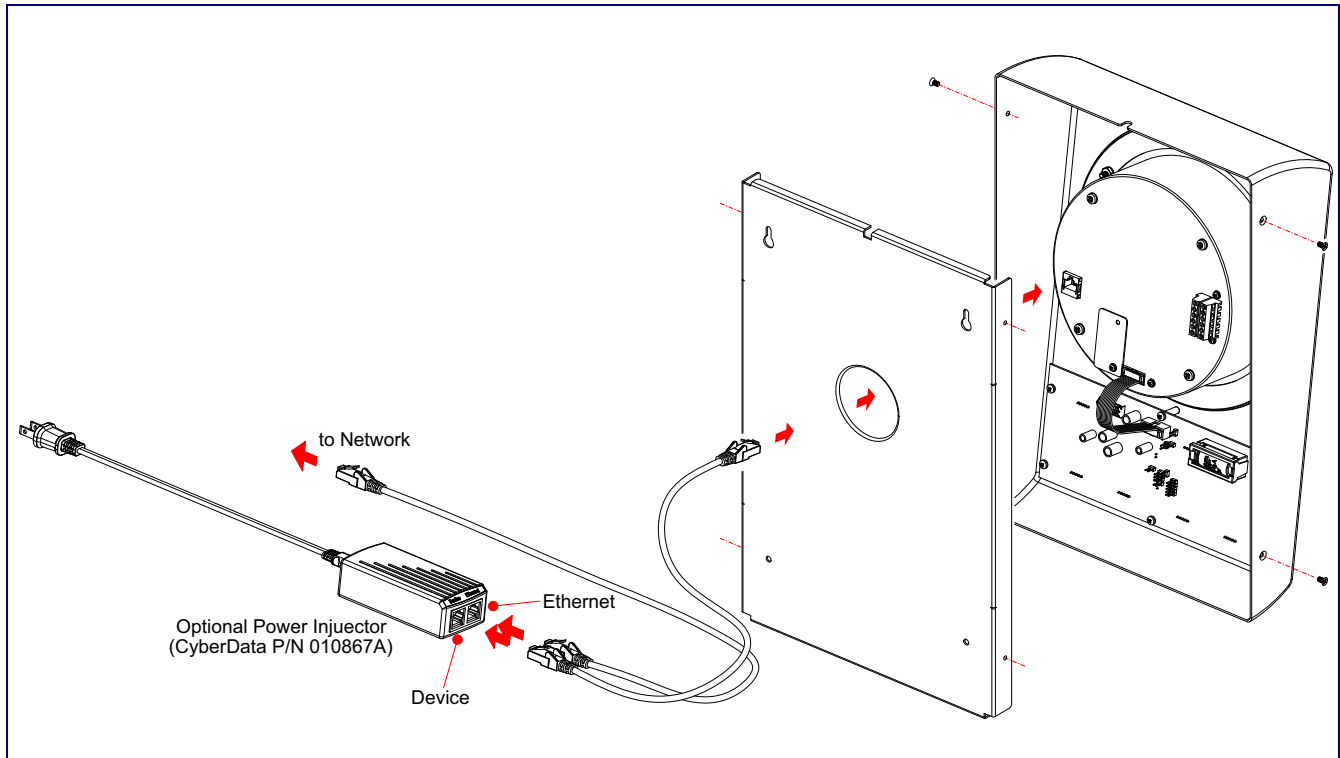


Figure 2-8. Connecting Power—Optional Power Injector



2.2 Verifying Operation of the Clock Kit Adapter

2.2.1 Identifying the VoIP Clock Kit Jumpers

Figure 2-9. Jumper Locations

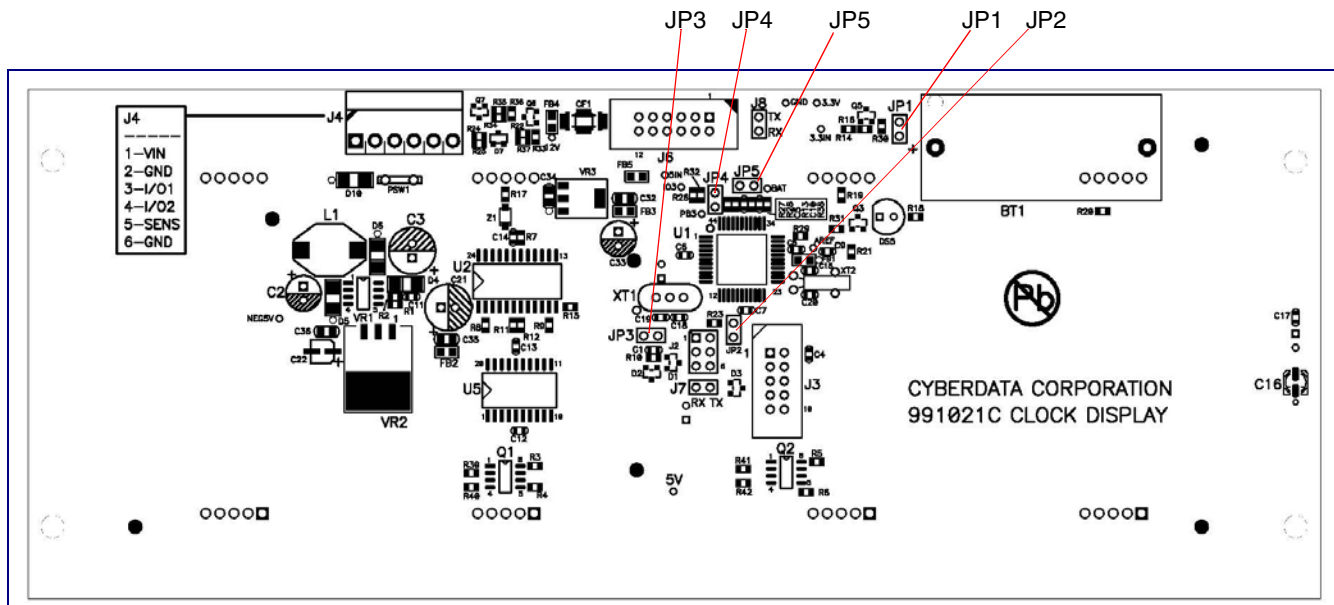


Table 2-1. Jumper Functions

Jumper	Function
JP1	Battery - Connect
JP2	Manufacturing - Open
JP3	Manufacturing - Open
JP4	Manufacturing - Open
JP5	Manufacturing - Open

Note Prior to installing the Clock Kit, make sure that JP1 is installed. This powers the Real Time Clock from the battery. If you do not, the clock will lose its time when the power is disconnected.

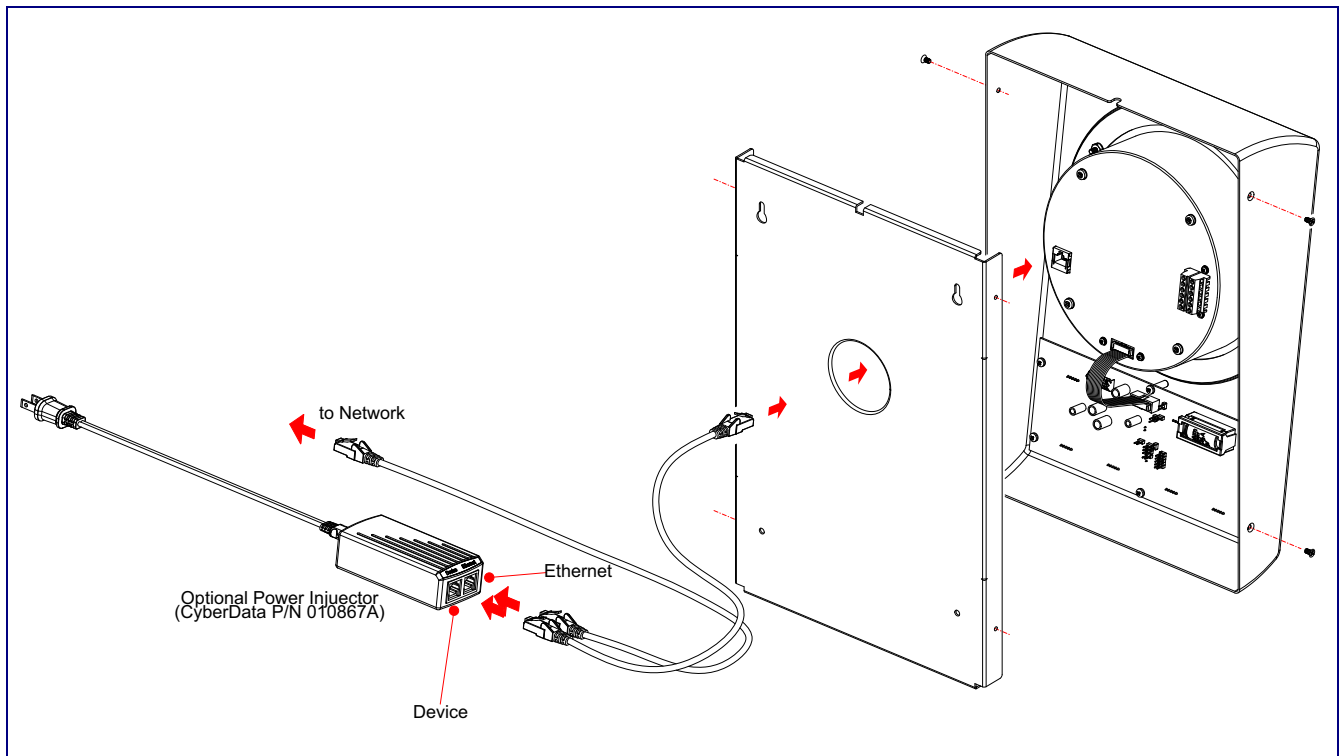
2.2.2 Power-Up Test

To perform a power up test,

1. Connect power to the speaker as shown in [Figure 2-10](#).

Note Prior to mounting, you can route the Ethernet cable through the back or through the slots at the top or bottom of the Clock Kit Adapter.

2. After connecting power, you will see one of the boot-up messages indicated in [Table 2-2](#).

Table 2-2. Clock Kit Boot-Up Messages

Message	Meaning	Action
8888	Normal start-up message.	None. Note: On the Clock Kit display, you will see the numbers 8888 for one second before displaying the time that is in memory.
E01	Time error	This would normally occur at manufacturing first Power On, or at subsequent Power On if the battery was low or dead. If it occurs more frequently, contact CyberData support. Note: If there is an Invalid Time Error, then you will see E 01 on the display for one second and the time will be reset to 00:00 .
E02	Low battery	Replace the battery. See Section 2.3.3, "Replacing the Clock Kit Battery" . Note: If the Clock Kit battery is low, then at power up, you will see E 02 on the display for one second before displaying the time that is in memory.

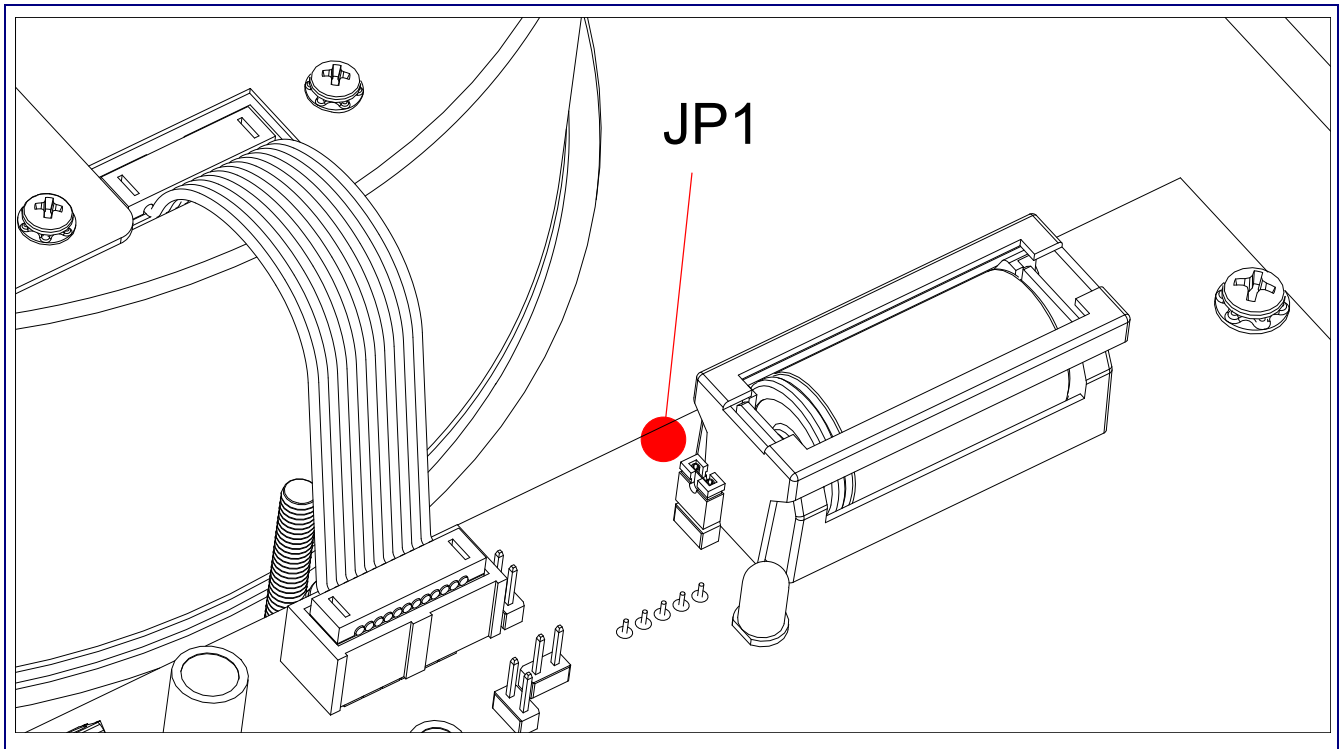
2.3 The Clock Kit Adapter Battery

2.3.1 JP1 Battery Enable Jumper for Real-Time Clock Operation

To enable the battery for real-time clock operation, install a jumper on JP1 as shown in [Figure 2-11](#).

Note This jumper ensures that the clock will not lose the time setting in the event of a power outage.

2.3.2 Checking the Battery Power Level of the Clock Kit Adapter

To check the battery power level of the Clock Kit Adapter,

1. Disconnect and reconnect power to the VoIP Speaker.
2. On the Clock Kit display, you will see the numbers **8888** for one second and then one of the following will occur:
 - If the battery power level is good, then the Clock Kit display will resume showing the time that is in memory.
 - If the Clock Kit battery is low, then you will see **E 02** on the display for one second before displaying the time that is in memory.

Note If there is an **Invalid Time Error**, then you will see **E 01** on the display for one second and the time will be reset to **00:00**.

2.3.3 Replacing the Clock Kit Battery

2.3.3.1 Battery Type

You should use a Lithium-Ion size 2/3A type battery with minimum 1000 mA-hr rating for the Clock Kit Adapter.

Acceptable replacements:

- Panasonic CR123A
- Duracell DL2/3A
- Sanyo CR17335SE

2.3.3.2 Battery Life

The Lithium-Ion CR-123 battery in the Clock Kit Adapter should last for approximately seven years.

2.3.3.3 Replacing the Battery

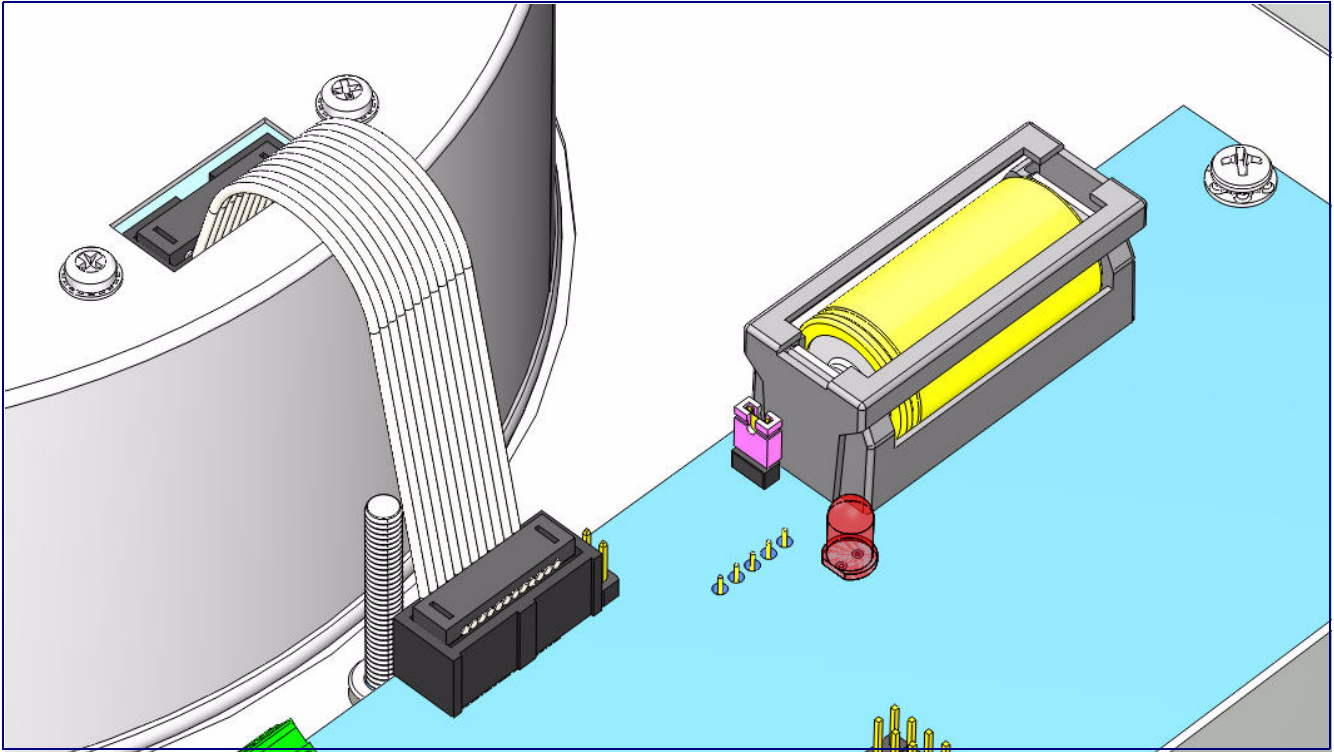
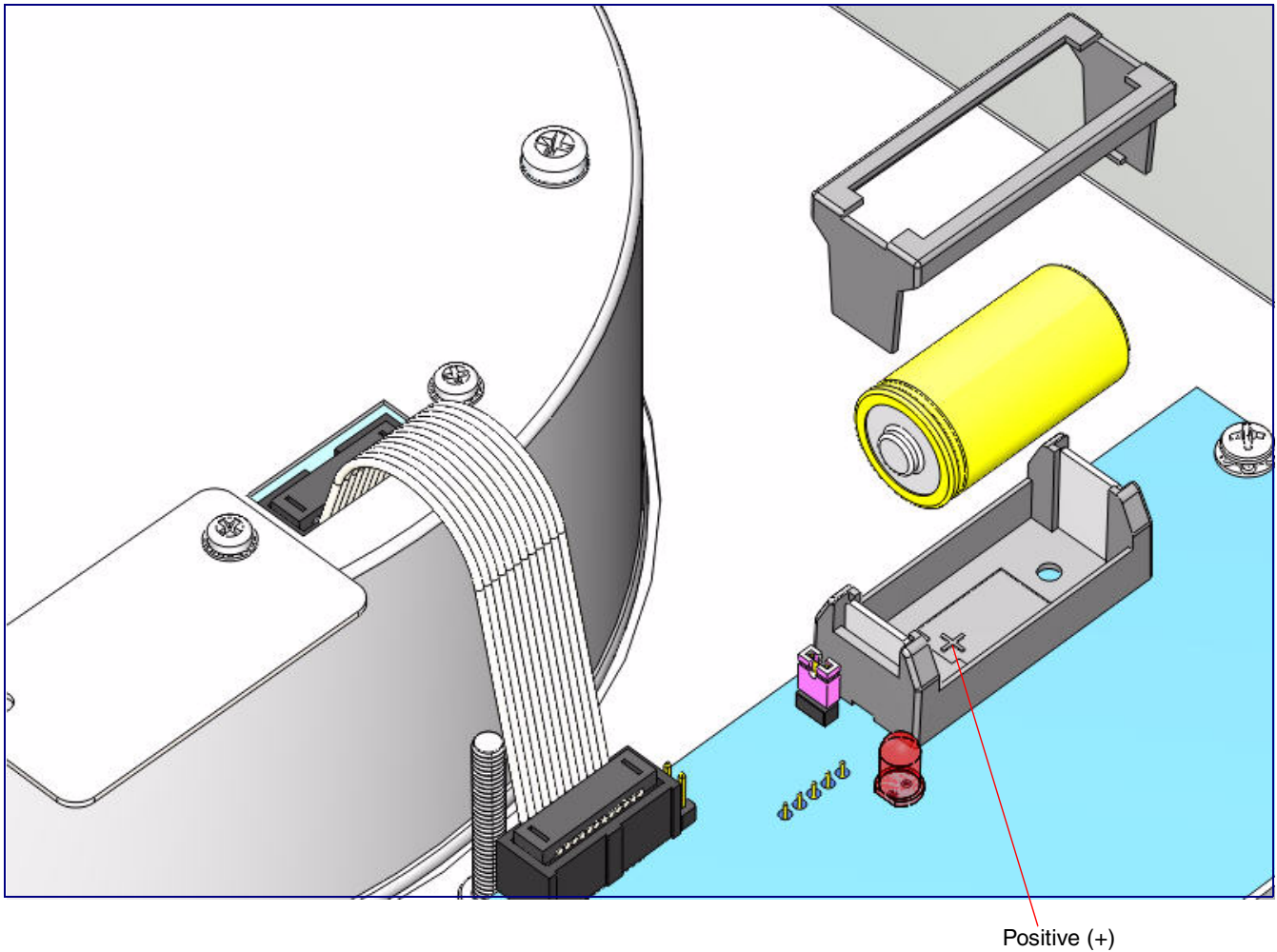


Figure 2-13. Clock Kit Battery Replacement

Figure 2-12 and Figure 2-13 illustrates how to locate and replace the Clock Kit battery.

Figure 2-12. Clock Kit Battery Location

2.3.4 Seconds Digits Blinking Fast

If the seconds digits on the Clock Kit display are blinking fast, then this means that the speaker has not communicated for more than one hour.




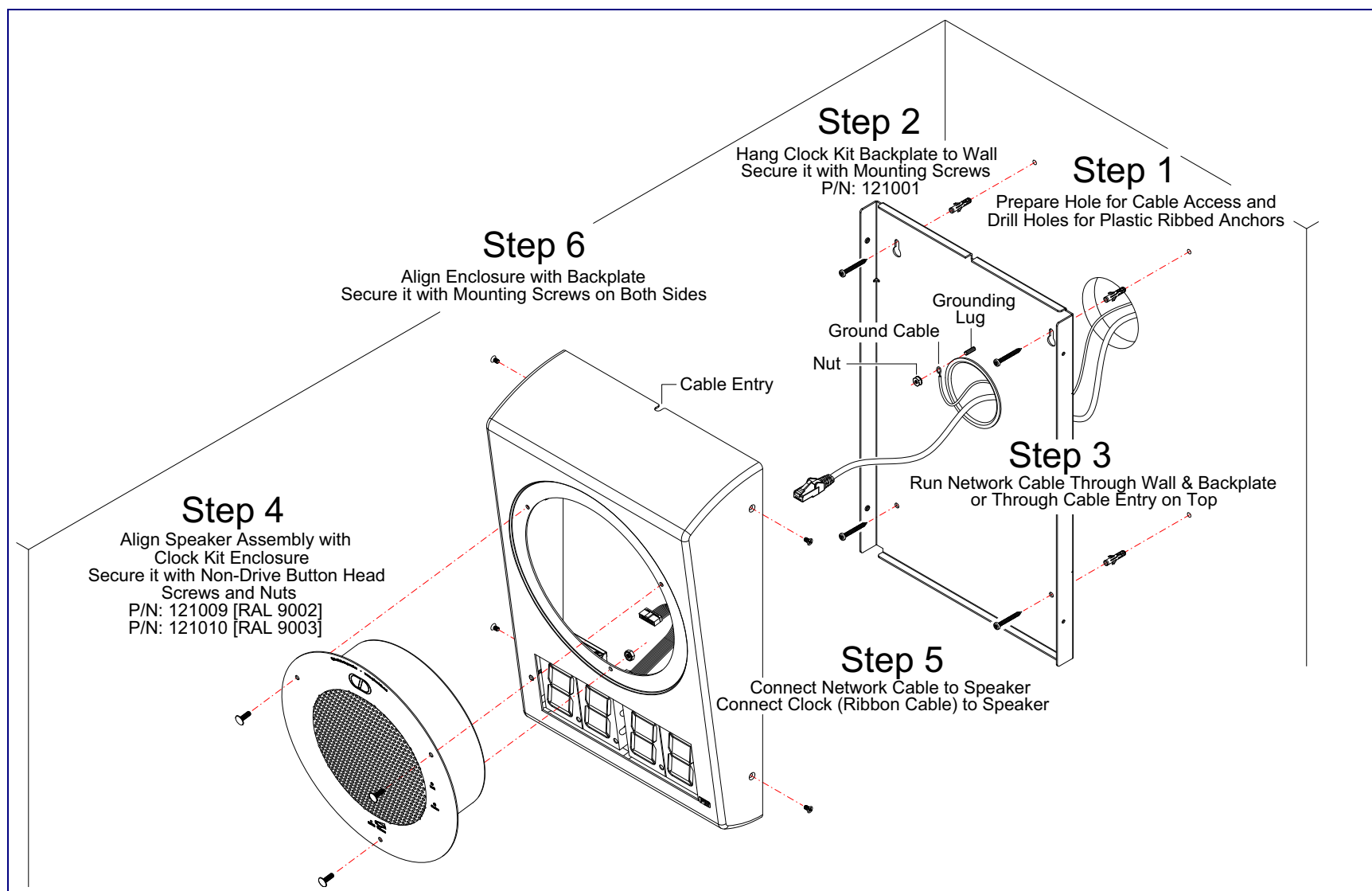
